

Information on the persons appointed to the Supervisory Board of Zespół Elektrowni Pątnów-Adamów-Konin S.A. ("ZE PAK S.A.") by the Extraordinary General Meeting on 22 March 2013

Mr. Ludwik Sobolewski

Graduate of the Faculty of Law and Administration of the Jagiellonian University (diploma with merit) and of PhD studies at the University Panthéon-Assass-Paris II (Diplôme d' Etudes Approfondies – D.E.A) PhD in law sciences (Jagiellonian University, 1995), legal advisor (1994), judge (application at the Court of Appeal in Krakow, 1990-1992).

In the years 1989-1995, he worked at the Faculty of Law and Administration of the Jagiellonian University, and, in the years 1992-1993, he worked in the Office of the Council of Ministers. In the years 1994-2006, he was Vice President of the Board of the National Deposit for Securities. From 28 June 2006 to February 2013, he chaired the Board of the Warsaw Stock Exchange.

From June 2006 to June 2008, he chaired the Supervisory Board of the National Deposit for Securities. From June 2008, he was Deputy Chairman of the Board, in 2009, he was re-elected as Chairman of the Board, Board member until January 2013, from June 2009 to January 2013, he chaired the Supervisory Board of BondSpot S.A. (formerly: MTS-CeTO). He was Deputy Chairman of the Supervisory Board of the Warsaw Stock Exchange Centre (2003-2006). In the years 2007-2009, he was a member of the Supervisory Board of WSEInfoEngine S.A.

He has performed numerous expert and advisory functions, inter alia: member of the Legal Certainty Group which was set up by the European Commission (2005-2006), from 2007, he sat on the Board of the National Centre for Research and Development, from 2006 to 2010, he chaired the Board of the Main State Bar Association, member of the European Centre for Comparative Commercial and Company Law (C-law.org Centre), co-worker of the Office of the Government Representative for Pension Reform, expert of the Senate and the Sejm committees, expert of the Senate Committee for the draft Act amending the Act on Investment Funds, co-worker of the Faculty of Management at the University of Warsaw.

In the years 2005-2006, he was a lecturer of the subject "Legal Aspects of the Managerial Decisions" at Executive MBA (curriculum of the Warsaw University and the University of Illinois). He has performed the function of judge of the Stock Exchange Court and of the Arbitration Court at the Polish National Depository for Securities.

He has completed different courses and trainings in the operation of capital markets, among others in the New York Institute of Finance.

He is the author and co-author of books and articles on capital market law and commercial law.

In 2000, he was honoured with the Knight's Cross of the Order of Polonia Restituta for academic achievements in the creation of grounds of capital market in Poland, and, in 2011, he was honoured with the Officer's Cross of the Order of Polonia Restituta.
